HYSBYSIR DRWY HYN, yn unol ag Adranau 30 ac 31 o Ddeddf Archwilio Cyhoeddus (Cymru) 2004 a Rheoladau Cyfrifon ac Archwilio 2005:

(1) O 12fed Gorfennaf 2010 tan 6ed Awst 2010 yn gynwysedig, rhwng 9.15y.b. a 4y.p. (Dydd Llun i Ddydd Gwener), ar ôl gwneud cais i'r Cyfarwyddwr Adnoddau, Cyngor Sir Caerfyrddin, Neuadd y Sir, Caerfyrddin, SA31 1JP, y gall unrhyw un sydd â diddordeb, archwilio a gwneud copïau o gyfrifon y Cyngor uchod am y flwyddyn sy'n diweddau ar 31ain Mawrth 2010, ynghyd â'r holl lyfrau, gweithredoedd, contractau, biliau, talebau a derbynbau perthnasol sy'n ymwneud â'r cyfrifon.

(2) Ar 9fed Awst 2010, neu ar ôl hynny tan ddiwedd yr Archwiliad, bydd yr Archwiliwr Apwyntiedig, Swyddfa Archwilio Cymru, 3ydd Llawr, Adeiladau'r Lyric, Heol y Brenin, Caerfyrddin, SA31 1BH ar gais unrhyw etholydd llywodraeth leol yn yr ardal y mae'r cyfrifon yn berthnasol iddi, yn rhoi i'r etholydd neu i gynnychiolydd yr etholydd gyfle i'w holi am y cyfrifon, a gall y cyfrifw etholydd neu ei gynnychiolydd e'fhi ymddangos gerbron yr Archwilydd i wneud gwrthwynebiadau:

(a) ynghylch unrhyw fater y gallai'r archwilydd weithredu yn ei gyflwr o dan adran 32 o'r Ddeddf, neu
(b) ynghylch unrhyw fater arall y gallai'r Archwilydd lunio adroddiad arno er budd y cyhoedd o dan adran 22 o'r Ddeddf.

(3) Ni ellir gwneud unrhyw wrthwynebiad oni bai fod yr Archwilydd wedi derbyn hysbysiad ysgrifenedig eisoes am y gwrthwynebiad hwnnw ac am y rhesymau dros wneud y gwrthwynebiad, a bod copi o'r hysbysiad hwnnw yn cael ei anfon at y corff sy'n cyflwyno ei gyfrifon i'w harchwilio.

AUDIT OF ACCOUNTS 2009/2010

NOTICE IS HEREBY GIVEN that pursuant to Section 30 and 31 of the Public Audit (Wales) Act 2004 and the Accounts and Audit Regulations 2005 that:

(1) From 12th July 2010 to the 6th August 2010 inclusive between the hours of 9.15 a.m. and 4 p.m. (Monday to Friday) any person interested on application to the Director of Resources, Carmarthenshire County Council, County Hall, Carmarthen, SA31 1JP may inspect, and make copies of the accounts of the above named Council for the year ended 31st March 2010 and all books, deeds, contracts, bills, vouchers and receipts relating thereto.

(2) On or after the 9th August 2010 until the conclusion of the Audit, the Appointed Auditor, Wales Audit Office, 3rd Floor, Lyric Buildings, King Street, Carmarthen, SA31 1BH at the request of any local government elector for the area to which the accounts relate, will give the elector or his or her representative an opportunity to question him about the accounts, and any such elector or his or her representative may attend before the Auditor to make objections:

(a) as to any matter in respect of which the auditor could take action under section 32 of the Act or
(b) as to any other matter in respect of which the Auditor could make a report in the public interest under section 22 of the Act.

(3) No objection may be made unless the Auditor has previously received written notice of the objection and the grounds on which it is to be made, and that a copy of such notice is sent to the body whose accounts are the subject of the audit.
