1. On 25 August 2010, and subsequently, until such time as the Auditor certifies the completion of the audit, local government electors from Conwy or their representatives will have the right to require the Auditor to give them an opportunity to question him about the accounts, and the right for them or their representative to attend before the Auditor and make objection to any of the accounts.
4. No objection may be made on behalf of the elector unless the Auditor has previously received notice in writing of the proposed objection and of the grounds on which the objection is made. A copy of the said notice to the Auditor must be sent to Conwy County Borough Council at the address below.
