## NOTICE OF TEMPORARY TRAFFIC ORDER

### NOTICE OF TEMPORARY 40 M.P.H. SPEED RESTRICTION ORDER ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14 A548 BAGILLT

The Flintshire County Council intends not sooner than 7 days from the 1st July 2010 to make an Order which will restrict the speed of all traffic in the following roads in Bagillt in the County of Flintshire to 40 m.p.h.

- A548 Bagillt dual carriageway west bound between the 40 m.p.h. sign at the east end and the 40 m.p.h. sign at the west end.
- A548 Bagillt dual carriageway east bound between the 40 m.p.h. sign at the west end and the 40 m.p.h. sign at the east end.

The reason for the restrictions is to facilitate the installation of ducts by Volkerinfra.

It is anticipated the Order will come into force on the 19th July 2010, or as soon as possible thereafter. The roads will only be restricted for four months, or until the earlier completion of the works, subject to a maximum period of eighteen months.

## FLINTSHIRE COUNTY COUNCIL

### (CEFN Y DDOL ROAD AND NEW ACCESS ROAD, ST.DAVID'S PARK, EWLOE) (PROHIBITION OF WAITING) ORDER 20-

The Flintshire County Council hereby gives notice that it proposes to make an Order under Section 1(1), 2(1) and (2) and 4(2) and (3) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the waiting of vehicles in the lengths of roads specified in the Schedule to this Notice.

Exceptions are provided in the proposed Order to permit waiting for the purposes of alighting, boarding, loading and unloading, removal of obstruction, works of maintenance, improvements, repairs and the like.

Exceptions are also provided in the proposed Order to allow vehicles displaying both a disabled persons badge and parking disc to wait in the lengths of roads specified in the Schedule, for a period not exceeding 3 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same day).

A copy of the proposed Order, together with a map showing the lengths of roads to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order may be examined at Room No.1393, County Hall, Mold, during normal office hours, and at Ewloe Post Office, The Highway, Ewloe, Flintshire CH5 3DN during normal opening hours.
