Sending a copy of that objection in respect of Renfrewshire Council to the Chief Executive, Renfrewshire Council, Renfrewshire House, Cotton Street, Paisley PA1 1WB or in respect of any of the above Bodies to the Clerk of the body concerned, Renfrewshire House, Cotton Street, Paisley PA1 1WD and to any officer of this authority or body who may be concerned.
- (d) The Auditor if requested to do so by any person objecting shall afford to that person, authority, or officer who may be concerned an opportunity of appearing before and being heard by the Auditor with respect to that objection and any such person may so appear or be represented.
